### **F2 DEPENDENT INFORMATION SHEET**

The spouse or unmarried minor children of an F1 visa student can be admitted in F2 status to accompany the student to the United States or follow to join the student at a later date.

In order to request a Form I-20 for your spouse/child, please submit the following documents to the Office of Admission and Records to the International Student Advisor, Shirley Jones via email at shirley.jones@calhoun.edu. The International Student Services Office will process your request within 3 business days after all requirements have been met to attend the college.

- 1. Photocopy of marriage license (spouse) and/or birth certificate (child)
- 2. Photocopy of passport for your spouse and/or child
- 3. Completed Affidavit of Support Form
- 4. Current Bank Statement in the amount of \$17,800 (for student) + an additional \$15,000 per year for first dependent (spouse/child), \$7,500 per year for each additional dependent

#### In order to apply for the F2 visa your spouse/child must have the following documents:

- 1. Valid F2 I-20, properly endorsed for travel (request at the International Student Services Office)
- 2. Valid Passport (must be valid for 6 month into the future)
- 3. I-901 SEVIS Fee receipt (print out at https://www.fmjfee.com)
- 4. Proof of current financial support (official bank letter & letter of financial support from your sponsor)
- 5. F2 Visa Support Letter (request from the parent, guardin, or sponsor)
- 6. Marriage Certificate (spouse) or Birth Certificate (child)
- 7. Photocopy of spouse or parent F1 Form I-20
- 8. Photocopy of spouse or parent passport
- 9. Photocopy of spouse or parent F1 visa
- 10. Transcript of F1 to verify full-time enrollment (Transfer Student, U.S. only)
- 11. F2 Visa Application Form (DS-160), Fees and Photographs (according to Embassy required format)
- 12. CONTACT the U.S. CONSULATE or EMBASSY in your country to schedule an appointment and to find out what other documents are needed for your F-2 visa application

#### **F2 Restrictions:**

- 1. Individuals in F2 status may not accept employment or engage in business under any circumstances.
- 2. F2 study is restricted. F2 children may only engage in full-time study at the K-12 level. F2 spouses may study part-time only (recreational or vocational).
- 3. Individuals in F2 status wishing to engage in full-time studies or are turning 21, must change their status to F1.
- 4. The F2 dependent status is only valid when the F1 student is in valid status.

# F2 Travel: F2 dependents planning to travel outside the U.S. must have the following documents for re-entry

- 1. Valid F2 Form I-20 with a valid travel signature not older than 12 months
- 2. Valid passport must be valid for 6 months into the future upon re-entry to the U.S.
- 3. Valid F2 visa
