CALHOUN BREAKS GROUND TO OCTOBER 2023 CELEBRATE BUSINESS EXPANSION

Calhoun Community College officials celebrated a milestone, breaking ground on the expansion of its cutting-edge Advanced Technology Center (ATC), located on the college's Decatur campus.

According to Dr. Jimmy Hodges, President of Calhoun, this expansion project was identified as a critical need through the Alabama Community College System (ACCS) ASPIRE 2030 initiative. This initiative engaged local and state legislators, college stakeholders, and the broader community to enhance Calhoun's focus on workforce training. Generously funded by ACCS, the project is being undertaken by all 24 ACCS community colleges across the state as a commitment to improving education by directing resources into essential upgrades and new constructions statewide.

"As a representative of the Alabama Community College System, we would like to express our gratitude to Calhoun for taking a leadership role in initiating the expansion of the ATC. Additionally, we commend Calhoun for selecting an architectural team capable of creating a blueprint that aligns with the requirements of our training programs. This building will enhance the college's existing training initiatives, and we at ACCS are grateful for the support of Senator Orr and his team in making this project possible," commented Mark Salmon, ACCS Chief Facilities Officer.

The new 57,200-square-foot building has a primary mission: To support training programs that will drive the growth of North Alabama's aerospace and advanced manufacturing industries.

"Recognized as the #1 advanced manufacturing degree-awarding institution, Calhoun remains a powerful workforce training entity in North Alabama," commented Hodges. "We are beyond grateful and excited to be chosen to house such a facility for our students, faculty, and staff, and could not have done it without the support of our ACCS team and local legislators."

"It takes a dedicated team of individuals to bring about significant milestones, and that's precisely how this building project came to fruition. I'm tremendously proud to have an outstanding team by my side and the opportunity to sponsor the \$30M bill, turning today's vision into a reality. These milestones genuinely excite me, as I firsthand understand the dynamic impact they will have on Calhoun's

students. Not only will they receive some of the best industry training in this region, but they'll also become skilled workers with valuable, lifelong skills that will keep our area's aerospace, engineering, machining, and manufacturing industries thriving for years to come," stated Senator Arthur Orr.

"The new state-of-the-art facility stands as a testament to Calhoun's Technologies Division's unwavering commitment to providing innovative training to our students and meeting the demands of our industry partners who seek specialized training for their future workers," says John Holley, Calhoun Technologies Dean. "The building is designed to accommodate specialized spaces for Calhoun's machine tool technology, welding, aerospace training, industrial systems and technology, Calhoun Workforce Solutions, and CDL training programs. Additionally, it will feature high-tech lab spaces, well-equipped classrooms, and modern administrative offices, all meticulously designed to facilitate optimal learning experiences."

"Thank you, Dr. Hodges, for your leadership and direction in working hand in hand with the community to prepare the workforce and fill jobs that are in great need of skilled workers," commented Representative Anthony Daniels. "During your short time at Calhoun, you have made significant strides in the community through training, providing opportunities for those who cannot afford to attend college and maintain their households through co-operative learning opportunities as well as through job placement. This is another feather in Calhoun's cap, and I am happy to have witnessed this event."

The Advanced Technology Center addition will equip Calhoun students with the vital skills needed to secure high-paying careers. This expansion also opens up the opportunity for students to earn nationally-recognized certifications at an affordable cost, further enhancing their professional prospects.

Goodwyn Mills Cawood will be responsible for providing architectural, interior design, civil engineering, and landscape architecture services for the new facility, while the actual construction will be undertaken by Bailey Harris Construction. The project is scheduled for completion by the spring of 2025.

STUDENTS EARN COLLEGE DEGREE BEFORE HIGH SCHOOL DIPLOMA

This year, Calhoun Community College saw four students who graduated with Associate of Science degrees from the College before obtaining their high school diplomas. An additional fifty high-schoolers earned short-term certificates in various disciplines from Calhoun also before obtaining high school diplomas.

"This should come as no surprise that the power of dual enrollment is truly undeniable," commented Dr. Jimmy Hodges, Calhoun President. "Each year, our dual enrollment numbers increase within our area high schools, and each year we produce work-ready students to industry before they are

even able to finish their high school diploma. These young people are learning hands-on skilled trades in all areas of technology, engineering, business, healthcare as well as cyber security and are ready to enter the workforce immediately."

According to Gwen Baker, Calhoun's Director of Dual Enrollment, during the 2022-23 academic year (summer, fall and spring) the College's dual enrolment program included over 2,050 students. Of that number, the following four students from Limestone and Morgan Counties qualified for graduation from Calhoun and earned an associate of science degree in the following disciplines:

HUNTSVILLE UTILITIES AND TVA LINEWORKER TRAINING SCHOLARSHIP PARTNERSHIP

MAY 2023

Huntsville Utilities and the Tennessee Valley Authority partner to provide \$100,000 in scholarship funding for training and educating utility lineworkers. Calhoun College Foundation, in cooperation with Calhoun Workforce Solutions, will manage the scholarships and enrolling students in the college's Pre-Apprentice Lineworker Program. The partnership was create to address the growth in the Huntsville-Madison County population, which led to a demand for services resulting in an increased need for utility.

"We have an immediate need for lineworkers and we need to get them trained right away," said Dr. Harry Hobbs, Vice President for Employee Engagement at Huntsville Utilities. "Workforce development is a priority for Huntsville Utilities as we continue to grow. We are excited about this opportunity to provide a path for individuals in our service area to receive training that could lead to a career in the utility industry.

TVA is the largest public power company in the United States providing electricity to 153 power companies like Huntsville Utilities. "TVA has over 16,000 miles of power lines that crisscross seven states plus approximately 263,000 miles of

lines that our 153 local power companies have. As electricity demand grows, we need a skilled workforce to provide clean, low-cost, reliable power," said Jared Mitchem, Regional Vice President for TVA South Region. "Partnering with Huntsville Utilities and Calhoun Community College ensures that we can recruit and train the workforce we need as we build the energy system of the future."

Huntsville Utilities and TVA contributed \$50,000 each to the scholarship. The training takes place at the Calhoun Lineworkers Pole Yard on the main campus in Decatur. The Madison County Commission provided a vehicle and a driver to transport students from Huntsville Utilities to the training site. The scholarships are earmarked specifically for the Huntsville Utilities service area, with the Calhoun College Foundation managing the funds.

"We are excited about this initiative and the impact it will have on the need for lineworkers," said Calhoun Community College President, Dr. Jimmy Hodges. "Our program provides the necessary skills and training desired by utility companies and contractors across North Alabama. In fact, most of our students have jobs waiting for them when they complete the program."

The scholarship recipients receive free tuition for the sevenweek lineworker course, including daily lunches. Upon graduation, students also receive a free tool bag equipped with climbing gear and basic lineworker tools. Calhoun's lineworker program course is offered five times per year.

CALHOUN ALUM CREATES ANNUAL MAY 2023 SCHOLARSHIP FOR STUDENTS WITH AUTISM

Calhoun Community College alum Holly Foshee worked with the college's foundation team to create a new annual scholarship that will help ease some of the financial burden for Calhoun students living with autism spectrum disorder.

"Being autistic almost crippled me from living a regular life," recalls Foshee as she spoke with foundation and college officials about her personal story. "I never thought I was excelling as a normal human being until my diagnosis".

Her college journey at Calhoun began in the spring of 1994 when she enrolled in a few classes, one being chemistry, as the goal was to take a few courses at Calhoun and then later transfer to The University of Alabama in Huntsville (UAH). Having a past history of struggling with standardized tests in high school, she remembered how patient the instructors were with her at Calhoun, making the transition into college testing somewhat a breeze. She was provided the opportunity to figure out calculus equations in a way that was comfortable with her learning style during coursework and tests resulting in her making A's. Upon obtaining her associate's degree in computer science at Calhoun, she became confident and went on to complete her bachelor's degree in computer science at Athens State University.

"A break was what I needed. I was burnt out and overwhelmed both physically and mentally with navigating through college," says Foshee. Her brother had taken a similar break while in college and it helped him. As she felt she was so much like him, she thought a break would help her too. During the break, she decided to work, which was a challenge. She found herself being fired from every job she had for having various autistic traits, with one huge red flag being constantly disengaged. At this point, Foshee explains she felt like a failure in life as she was unable to hold down a steady job, thus causing her to become homeless and down on her luck. So she felt enrolling back into college was the answer.

Back to where she felt comfortable, she enrolled at Calhoun in 2004 and took a few courses that would help her obtain a bachelor's degree in mechanical engineering at UAH, which she later earned in 2011. Still in between jobs as well as being homeless, Foshee immediately enrolled back into UAH to earn her master's degree in mechanical engineering with a concentration in biomechanics. Six years later, she earned her degree in 2017, but the excitement of finally obtaining that degree after such a long journey, suddenly turned dim and Foshee knew she really needed to seek answers that would solve the mystery of why she thought and felt differently than others. "There were times I had many thoughts such as why I existed or what I needed to

survive day to day," Foshee says. "Those daunting questions I needed answers to and quick. Struggling to feel comfortable enough to share with people that I was homeless while in college made my life very, very difficult."

Things began to look up for her as she became gainfully employed with a full-time job. One day, her employer asked to have a conversation with her, which made her nervous as she thought she was on the verge of being fired as she had been from every other company where she worked. This time, the conversation was different. It was one of both genuine concern and compassion about her work habits. That conversation along with the many other life events and challenges encouraged her to get tested for being autistic. In 2017 she received a confirmed diagnosis as well as the appropriate paperwork to provide to her employer.

"I needed that diagnosis not only to ensure I would receive the accommodations I needed as an autistic person to excel in my job but for my own inner peace. And on the day of my diagnosis, that is what I received," she said smilling. She currently speaks at various organizations, including her current employer, to educate and spread awareness to individuals about autism and those who may be on the job or in the classroom living with it.

Foshee believes that many individuals struggling with autism may not understand what types of financial aid are available to help them obtain their college degree, and doesn't want them to go through what she did financially, which is why she decided to create the scholarship. "I was so determined to create this scholarship that I sold many of my personal belongings and received help from a few other individuals living with autism who believed in my mission and wanted to help me come up with the first \$1,000 dollars to begin the annual scholarship. In order for this scholarship to accomplish the goal of helping autistic individuals who won't qualify for academic scholarships that require a certain ACT or GPA, we need business leaders and individuals in the community to help contribute. This scholarship could be someone's lifeline to not give up on their dreams of graduating from college."

CALHOUN AND ATHENS STATE SIGN MOU ON ACCELERATED NURSING DEGREE PROGRAM

APRIL 2023

On April 24, Calhoun Community College and Athens State University signed a Memorandum of Understanding to establish a new fast-track BSN program that will allow students to receive their Associate Degree in Nursing (ADN) and Bachelor of Science in Nursing (BSN) degree simultaneously. In addition to better serving students, the program's benefits will extend to the consumers of healthcare and professional nursing workforce across the nation.

"With the nursing shortage crisis continuing to rise in North Alabama, it made perfect sense for Calhoun and Athens State to team up and establish a program that will not only help our students to earn their nursing credentials, but to earn them as quickly as possible," commented Dr. Lynn Hogan, Calhoun Nursing Department Chair.

Students completing the program will be enrolled in nursing courses concurrently at both institutions and will graduate from both Calhoun with an Associate Degree in Nursing (ADN) and Athens State with a Baccalaureate of Science Degree in Nursing (BSN) in separate ceremonies with separate diplomas.

"The Fast-Track BSN is an excellent option for motivated nursing students at Calhoun Community College," said Dr. Mark Reynolds, Chief Nurse Administrator at Athens State. "This option provides both a time and cost-saving for the nurse to gain additional skills and expertise along with the ability to move into advanced-practice education expeditiously.

The collaborative efforts between both institutions indicates a commitment to the region to produce quality Registered Nurses who are prepared to provide quality patient care."

"Our community and nation needs highly trained nurses now more than ever," said Dr. Dave Ragsdale, Dean of the College of Arts and Sciences at Athens State. "This partnership between Calhoun and Athens State responds to that demand by delivering more nurses to the workforce as well as enhanced patient care to our healthcare systems during this critical time."

CALHOUN RECEIVES OVER \$250K GRANT FOR MERGING ART WITH TECHNOLOGY AND ENGINEERING PROGRAM APRIL 2023

The Appalachian Regional Commission (ARC) has awarded a grant in the amount of \$108,000 to Calhoun Community College for its STEAM Project. In addition to ARC funds, local sources will provide \$144,356 bringing the total project funding to \$252,356.

According to Dr. Debi Hendershot, Calhoun Dean for Planning, Research and Grants, the grant funding will be used specifically for the College's STEAM: Merging Art with Technology and Engineering project. The sole purpose of the project is to assist with reinforcing existing programs and developing new programs in STEAM at Calhoun that will help teach the skillsets desired by North Alabama businesses in Lawrence, Limestone, Madison and Morgan counties.

The STEAM project will also help to support Calhoun's existing Additive Manufacturing, Visual Communications, and Computer Information Systems programs, as well as the development of new Design Innovations and Video Game Design programs at the Alabama Center for the Arts in downtown Decatur. A challenge in the thriving, high-tech region of North Alabama is the need to fill an ever-growing job market. The area is diverse with aerospace and defense, manufacturing, cybersecurity, and healthcare industries. This project will focus on merging technology and engineering with arts to train students for current and future jobs in high-demand fields. The College has designed an Associate of Applied Science degree to interweave those fields together so

that students are employable upon graduation or are ready to matriculate to a four-year institution.

"We have to remain forward-thinking regarding how we educate and train our students," commented Dr. Jimmy Hodges, Calhoun President. "Students from this region find themselves having a love for engineering, but also a love for the arts. We've learned how to combine the two fields without the student having to sacrifice one for the other," he added.

This program will serve traditional, non-traditional and dualenrolled high school students, as well as those students returning to college for a second career. The College will purchase the information technology supplies as well as state-of-the-art computers and software that are being used in today's market. This will provide students with a real-world training environment to learn and become comfortable in as if they were on the job.

CALHOUN AND UAH SIGN ADVANCED MANUFACTURING MOU

Academic officials from Calhoun Community College and The University of Alabama in Huntsville (UAH) signed an Advanced Manufacturing Memorandum of Understanding (MoU).

In the fall of 2019, Calhoun opened the Alabama Center for Additive Manufacturing Excellence (ACAME), which is a division of Auburn University's National Center for Additive Manufacturing Excellence (NCAME). This facility also has a host of partners such as Auburn University, GE, Huntsville City Schools, NASA, and UAH, who assist in curriculum development.

"As the only educational institution in the state of Alabama to offer an Additive Manufacturing Design degree, one of our goals was to collaborate with our ACAME partners. Thus, the MoU signing was a no-brainer after many discussions with the team," says Mrs. Nina Bullock, Technologies Department Chair and Design Drafting Technology Instructor. "The mission of the MoU is to create a seamless transferable career path for those students in the program to transfer to UAH."

While elements of manufacturing and design are regularly taught in classes at Calhoun and at 4-year universities, the interaction between students trained in different fields is currently lacking.

"This agreement not only offers a solution that spans cross-disciplinary and inter-disciplinary, but also with multi-disciplinary techniques for remediation," commented John Holley, Calhoun Dean of Technologies.

THE FOUR MAIN OBJECTIVES OF THE PROPOSED PLAN INCLUDE:

-TEAMING STUDENTS FROM THE ASSOCIATE'S PROGRAM AT CALHOUN WITH BACHELOR'S-DEGREE STUDENTS AT UAH ON CAPSTONE PROJECTS INCORPORATING ADVANCED MANUFACTURING (AM) AS PART OF THE DESIGN REALIZATION:

-ENGAGING GRADUATE STUDENTS IN DEVELOPMENT OF MODULES FOR INCORPORATING INTO EXISTING CLASSES TO CONNECT ENGINEERING CONCEPTS WITH THE DEMANDS OF THE AM ENVIRONMENT;

-INSTALLING ADVANCED INSTRUMENTATION ON EXISTING AM EQUIPMENT TO SUPPORT RESEARCH EFFORTS INTO QUALIFYING CERTIFYING AM COMPONENTS; AND

-OFFERING A SERIES OF SHORT COURSES FOR LOCAL INDUSTRY TO DISSEMINATE THE LATEST TRENDS IN AM.

This diverse, inter-disciplinary, and multi-disciplinary approach proposed will provide a direct pipeline of future employees to support Alabama industry from Alabama colleges and universities. Integration of activities with industry input provides the necessary link between theory and practice.

SPEAKER FOR ANNUAL MLK PROGRAM SHARES PERSONAL JANUARY 2023 MEMORIES OF DR. KING

Calhoun Community College paid tribute to slain civil rights leader, Dr. Martin Luther King, Jr., during the college's annual celebration program held January 18. This year's program, hosted by the college's Black Student Alliance (BSA) Club, was held in the Student Center on Calhoun's Huntsville campus. This year's program speaker was Jawana V. Jackson, CEO of The Sullivan and Richie Jean Sherrod Jackson Foundation and Museum, Inc.

To many, Dr. Martin Luther King, Jr. is referred to as one of the nation's most significant civil rights leaders, a Nobel Peace Prize recipient, or a Grammy Award-winning author. But to Jawana V. Jackson, he is affectionately referred to as 'Uncle Martin'. In Selma, Alabama, Jackson was born to the late Dr. Sullivan Jackson and Richie Jean Sherrod Jackson who were close friends to Dr. and Mrs. King. Growing up, Jackson recalls the Kings staying in her childhood home during 1964 and 1965 to plan the logistics of the historic Selma to Montgomery March. History reveals that her childhood home became the headquarters for Dr. Martin Luther King, Jr. as well as many other prominent civil rights leaders.

As a young child, Jackson witnessed American history take place in her home as it relates to the voting rights movement in this country. Her parents' close association with prominent world leaders as well as their contributions to both civil and social rights forged her commitment to the principles of justice, peace and freedom. Her childhood home in Selma, Alabama contains original artifacts dating back to the mid-1800's which depict a rich narrative of African-American life in the south and the struggle for voting rights. The Juanita Richardson Sherrod Solitude Art Collection, which contains over 60 original oil paintings created by

Mrs. Jackson's grandmother, is also on display in the home. The Jackson Home is listed on The National Historical Register, The Alabama Register of History and Landmarks and The National Park Service's Selma to Montgomery Trail. Following in her parent's footsteps and the other great leaders she was influenced by during her childhood, Jawana attended Fisk University where she earned a bachelor's degree in Psychology as well as completed some master's degree work in Gerontology. She went on to become the Director of Visitor Services for The Martin Luther King, Jr. Center for Nonviolent Social Change in Atlanta, Georgia, under the leadership of Mrs. Coretta Scott King, and served for 10 years. In 1996 she accepted a position in Government and Community Relations with The Metropolitan Atlanta Rapid Transit Authority, which she held until 2007.

In 2011, Jackson's mother published a book titled The House by the Side of the Road: The Selma Civil Rights Movement to document the events that occurred in their home. Jawana later created The Sullivan and Richie Jean Sherrod Jackson Foundation and Museum, Inc., which is a nonprofit organization dedicated to preserving the historic home and her parents' contributions to our nation. She also serves as a gatekeeper for this home recognizing its invaluable history. She is deeply committed to the cause of social justice and wishes to promote positivity by encouraging others.

She considers it her mission "to find paths for people to build bridges of understanding thereby strengthening the fabric of our world community for humankind to exist in peace with justice and freedom."



CALHOUN COACHES EARN TOP HONOR FOLLOWING HISTORIC SEASONS

A pair of Calhoun Community College coaches were given the Alabama Community Colleges Conference's top honor in 2023, following historic campaigns on the basketball and volleyball courts. Warhawk women's basketball coach Candace Byrd-Vinson and volleyball coach Jamiee Freeman were both named the ACCC Coach of the Year by their peers following the conclusion of the regular season in each sport.

In her first season in charge of the Lady Warhawks, Byrd-Vinson took over the program after it had been on hiatus for more than 20 years, and immediately led the team to success both overall and in league play. The Warhawks completed their first season with a record of 17-12 for the year, including a 13-6 mark in ACCC play, earning a spot in the ACCC Tournament in March, which was held on the campus of Alabama A&M University.

Prior to the start of the tournament, Byrd-Vinson was honored with the Coach of the Year award on the floor of Alabama A&M's new basketball arena.

The Warhawks went on to defeat Bishop State by a score of 83-74 in the quarterfinals, ending the season on a 9-3 stretch. In addition to Byrd-Vinson earning the league's top coaching honor, standout Kennedi Hawkins was named to the ACCC All-Region Team, earning a spot on the first-team, recognized as one of the five best players in the league.

Freeman, in her second season in charge of the Warhawk spikers, engineered one of the biggest turnarounds in league history on her way to being named the conference's volleyball Coach of the Year winner.

Freeman, who put together the first volleyball team in Calhoun history in 2022 on just a couple months' notice, jumped from a 7-17 mark in the first season, to a 31-11 mark in 2023, which included going 10-2 in ACCC matches, finishing in second place in the ACCC North Division.

The 24-win improvement was the largest in the conference, and the school's 31 wins were the second most among the league's 13 volleyball teams.

Under Freeman's guidance, the Warhawks qualified for the ACCC Tournament held at Coastal Alabama, where they won two matches, sweeping both Coastal Alabama-North, and Pearl River (MS) Community College on their run to the semifinals.

Calhoun saw three players earn All-ACCC honors for the season, Allyse Rudolph was named to the first-team, while Ariel Fuqua and Raegan James both earned second-team honors.



CALHOUN STUDENTS ADVANCE TO THE FINAL FOUR OF NATIONAL COMPETITION

Calhoun Community College saw its advanced manufacturing team has been named among the final four teams to compete in Project MFG's National Advanced Manufacturing Championship and was also featured in the reality web series, Clash of Trades.

According to Project MFG, schools from across the nation competed in a challenging season of Project MFG's Integrated Advanced Manufacturing Competition series. These competitions aim to change the perception of skilled trades and promote successful careers throughout the manufacturing industry. Manufacturing touches many aspects of our daily lives, which include transportation, medical, technology, and defense to name a few. These critical industries are facing a huge shortage in not only workers who are interested in the career field, but individuals who possess the skills needed to perform the jobs, thus potentially leaving more than 2 million positions unfilled across the nation. The lack of interest and engagement from the younger generations is an important factor in that statistic, and Project MFG has created this nationally-recognized competition to change that perception.

"I can't begin to explain how milestones such as these are testaments to the effectiveness of the advanced curriculum our technologies programs continue to produce for our students," commented Tad Montgomery, Calhoun Technologies Instructor. "Our students continuously go the extra mile in learning all the vital components of their programs and use

those skills to compete among the best of the best across the nation in these types of competitions. These platforms not only provide our students with real-life scenarios and teach them how to use the skills they've obtained in their programs, but also help us to improve our program training as well."

This past February, 16 teams competed in the regional rounds that took place at Calhoun Community College, Southwestern Illinois College and Wichita State University Technical College. Competing schools were faced with real-world scenarios and pressure tested to demonstrate the critical skills needed to succeed in modern advanced manufacturing. The teams were challenged to complete a project that consisted of machining multiple pieces on a 5-axis machine and welding a pressure vessel.

"Student teams who participate in these types of competitions give us hope, as we are watching the next generation of skilled trades professionals develop each time we make these types of events possible to attend," said Montgomery.

The final four teams who will battled head-to-head for the National title were Calhoun Community College, Minnesota State College Southeast, Southwestern Illinois College, and Thaddeus Stevens College of Technology. The competition took place at the Greenville Technical College Center for Manufacturing Innovation Center on May 8-12 in Greenville, South Carolina.
